Discussion was also held to determine if there is any recourse for the current water complications. It was decided not to pursue but John will follow up with Rich to get his opinion on our water

repair contractors and he will follow up with Bruce. Jeannette also asked Bruce to follow up on our CPA and Attorney contacts.
